Terms and Conditons

WHAT WE PRODUCE:

T-shirts, hoodies, sweatshirts, joggers, sportswear, chinos, denims, jackets and other outwear styles.

We can also make a variety of shoes and socks.

We work with 100% Cotton and Mixtures, light-weight and heavy-weight. We also work with jersey, jersey/lycra, piquet, fleece, mixtures with lurex as well as woven fabrics.

WHAT WE MANUFACTURE:

We manufacture products with all types of garment wash and garment dye. We also work with all types of printing techniques and embroidery.

WHAT INFORMATION WE NEED FROM YOU AS A COMPANY/BRAND?

You need to provide us with your company name, billing address, delivery address (if different) and your VAT number (Or similar number if you're outside Europe - Ex: ABN for Australia or EIN for United States). If your company does not have a VAT number (or others stated above), we are unable to accept your project nor provide a quote.

HOW FAST CAN YOU DEVELOP SAMPLES/PRODUCTION?

Depending on our production schedule and the model (also if we use the fabrics in stock), we can normally develop the sample in 4-6 weeks. For production we normally have a delivery time of 8-10 weeks after receiving the final order and payment confirmation of the exact order. These deadlines are pending confirmation depending on project complexity. All samples have a development cost, that will be confirmed once your specs are shared with our team. All customizations required that are not ordered on the sample stage will be applied in production directly without a sample for confirmation under clients responsibility. Alternatively.

HOW DO YOU HANDLE SHIPPING?

Our company is not responsible for shipping. We can arrange shipping under our account if you don't have the means to arrange this (for this you will be charged). We do not assume any responsibility for damages, loss and custom charge fees that may occur. Oasistyle sells FOB, this means that as a manufacturer we are no longer responsible for your product once your product leaves our facilities. Productions are all shipped in one single drop for an address in the same country as to where your brand/ company is registered. We do not make dropship. Shippings costs are provided once the parcel being shipped is packed and we have the information regarding volume/weight of the shipping. Any issues with shipping must be handled directly between the consignee and the transport company. All shipping does not include insurance unless required otherwise, which will have an associated cost. All shipments after leaving our facilities are governed by the UPS/DPD/FedEx/GLS/DHL Terms and Conditions of Transport. In the event of loss of uninsured merchandise, compensation corresponds to that established in the CMR or the Warsaw Agreement. The customer must always inform the shipping address when the order is placed and payment is confirmed. If Oasistyle does not have this information in a timely manner, we will send it to the billing address. It is the customer's responsibility to provide the shipping address and any changes thereto as carriers do not accept changes after the cargo has been collected.

WHAT ARE YOUR MINIMUM QUANTITIES?

We do not have minimum quantities, except for some specific products Some specific fabrics are custom-made and can range from 300 pieces per color to 1000 or higher.

CAN YOU SEND US FABRICS TO HELP US CHOOSE A MATERIAL?

We can send fabric swatches if you provide the composition, structure and weight that you are looking for. We can also provide guidance and suggest fabrics that could fit well with your project/budget. If you are unable to provide the information, you can send us a fabric sample where we can source something similar.

HOW DO YOU USUALLY OPERATE WITH YOUR CLIENTS (PROCESS/INFORMATIONS YOU NEED/SOURCING ETC)?

We have a total vertical process of creation, from fabric sourcing, fitting, patterns, prototypes, printing techniques/embroidery up to the final stages of production and packing. From you as a brand, we need either full technical packs for each model or physical samples for fitting/fabric reference.
